WHY THESE INFORMATION

In this document we inform you about the regulations in force, how to manage personal data relating to users who browse on this site.

Pursuant to Regulation (EU) 2016/679, this document describes the methods for processing personal data of users who visit the www.royalblutavel.com website for the protection of personal data.

COOKIE RULES

The site www.royalblutavel.com does not store data of its users but uses only technical and analytical cookies (not profiling related to marketing actions) because it uses the Google Analytics tool. Below is the privacy statement of Google Analytics.

- Technical cookies do not collect user information or track web browsing.

Data provided by the user voluntarily

The sending of e-mails to the addresses shown on the site by the users entails the collection of the sender's email address by Royal Blu Travel Cooperativa a.r.l. without this data being stored in the database of the namesebob, but exclusively to respond to the request, as well as any other personal data contained in the communication used only to reply to the e-mail message.

The shipment of electronic forms (eg the FORM for data entry) for requests for information involves the collection by Royal Blu Travel Cooperativa a.r.l. of personal data included in the form itself without this data being stored in the database of the sitename but sent through a mail communication of email. Personal data collected through this method will only be used to confirm the request for information received and for any subsequent related communications.

It also has the right to revoke the authorization to process the data for which it has given consent, as well as the right to lodge a complaint with the Authority for the Protection of Personal Data.
